01. OVERVIEW

Currently, VNSTEEL operates under the model of a Joint Stock Company with nearly 40 subsidiaries, joint ventures and affiliates.



VNSTEEL operates mainly in the fields of steelmaking, trading materials and equipment related to the steel industry; In addition, there are other business activities such as financial investment, port operation, logistics, warehousing, leasing of factories, offices, houses; Investment in infrastructure of industrial parks, urban areas and real estate; Labour export...

4. IMPORTANT MILESTONES

April 29, 1995: Prime Minister signed Decision No. 255/TTg to establish Viet Nam Steel Corporation on the basis of consolidating and merging many enterprises and units in the steel production industry, including Steel Corporation under the Ministry of Industry and Metal Corporation under the Ministry of Trade.

November 23, 2006: Established the parent company - Viet Nam Steel Corporation.

2007



June 21, 2007: The Prime Minister approved the Charter of Organization and Operation of the Parent Company Viet Nam Steel Corporation

July 1, 2007: The Corporation operated under the model of the parent company - Viet Nam Steel Corporation and changed the brand identity system

2009



December 31, 2009: Government Office issued Official Letter No.373/TB-VPCP announcing the Prime Minister's conclusion: "Agreeing to equitize the parent company of Viet Nam Steel Corporation, the State holds over 65% of charter capital"

2010



October 15, 2010: The Minister of Industry and Trade issued Decision No. 0256/QD-BCT on the equitization of the parent company - Viet Nam Steel Corporation

2011



October 1, 2011: Viet Nam Steel Corporation VNSTEEL officially switched to operate under the model of a joint stock company, with a charter capital of 6,780 billion VND, of which the State capital was 6,368 billion VND, accounting for 93.93% charter capital. The representative agency for state capital owners was the Ministry of Industry and Trade.

January 18, 2016: Viet Nam Steel Corporation officially started IPO

2019



April 19, 2019: The right to represent the owner of the State Capital at Viet Nam Steel Corporation was transferred from the Ministry of Industry and Trade to the State Capital Investment Corporation (SCIC)
